Norfolk Electoral Board  
March 4-9, 2020

The canvass of the March 3 Presidential Primary was to order by the Chairman, Mike Ziegenfuss, at 10:17 a.m., March 4, 2020. Present were Chairman Ziegenfuss, Vice Chair Michael Khandelwal, Secretary Barbara Klear, and Director of Elections Stephanie Iles.

It was moved by Michael Khandelwal and seconded by Barbara Klear to allow the staff to do necessary research on the results for each precinct. The motion passed unanimously.

The canvass recessed for lunch at 12:20 p.m and reconvened at 1:40. The canvass recessed for the day at 4:30 p.m. The canvass will reconvene at 10:00 a.m., March 5, 2020.

Chairman Ziegenfuss called the canvas to order at 10:11 a.m., March 5, 2020. Present were Mike Ziegenfuss, Vice Chairman Michael Khandelwal, Secretary Barbara Klear, and Director of Elections Stephanie Iles. The canvass was recessed at 2:45 p.m., March 5, 2020 until 11:00 a.m., March 9, 2020 to review provisional ballots.


The Chair reconvened the canvass at 11:03 a.m., March 9, 2020. Present were Mike Ziegenfuss, Vice Chairman Michael Khandelwal, Secretary Barbara Klear, and Director of Elections Stephanie Iles.

There are 69 provisional ballots – 13 photo ID and 56 other. The review found:

1. 14 were registered in another precinct. It was moved by Michael Khandelwal and seconded by Barbara Klear to not accept. The motion was approved unanimously.
2. 14 were registered in another jurisdiction. It was moved by Michael Khandelwal and seconded by Barbara Klear to not accept. The motion was approved unanimously.
3. 18 were not registered in Virginia. It was moved by Michael Khandelwal and seconded by Barbara Klear to not accept. The motion was approved unanimously.
4. 7 did not submit their photo ID by the 12 p.m., March 6, 2020 deadline. It was moved by Michael Khandelwal and seconded by Barbara Klear to not accept. The motion was approved unanimously.
5. 7 requested an absentee ballot, but did not surrender it at the polls. It was moved by Michael Khandelwal and seconded by Barbara Klear to accept. The motion was approved unanimously.
6. 6 had no photo ID, but provided a photo ID by the 12 p.m., March 6, 2020 deadline. It was moved by Michael Khandelwal and seconded by Barbara Klear to accept. The motion was approved unanimously.
7. 1 had moved within the precinct and did not need to vote provisional. It was moved by Michael Khandelwal and seconded by Barbara Klear to accept. The motion was approved unanimously.
8. 1 was not in the pollbook. This was an address issue and pollbook worker error. It was moved by Michael Khandelwal and seconded by Barbara Klear to accept. The motion was approved unanimously.
9. 1 was a mother/son issue and checked in under the wrong name. It was moved by Michael Khandelwal and seconded by Barbara Klear to accept. The motion was approved unanimously.

With the addition of the accepted provisionals, the results were calculated. The abstracts were prepared and signed.

With no further business, the canvass was adjourned at 3:30 p.m., March 9, 2020.
